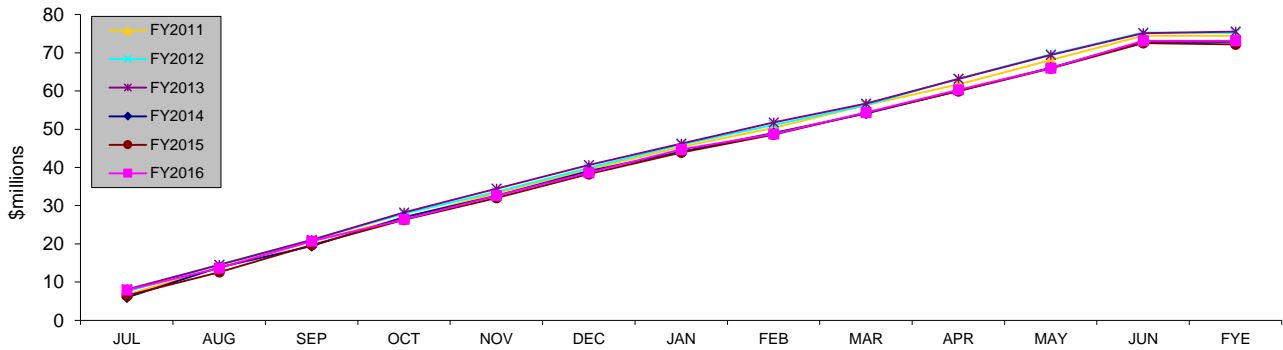

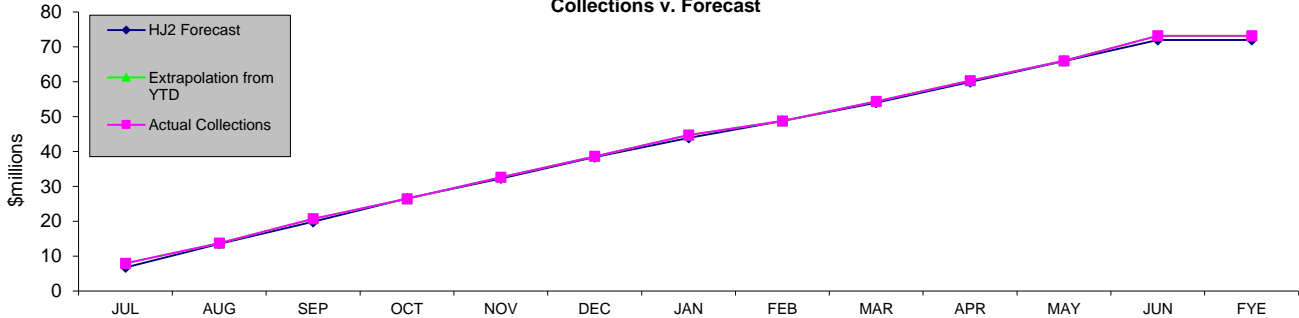

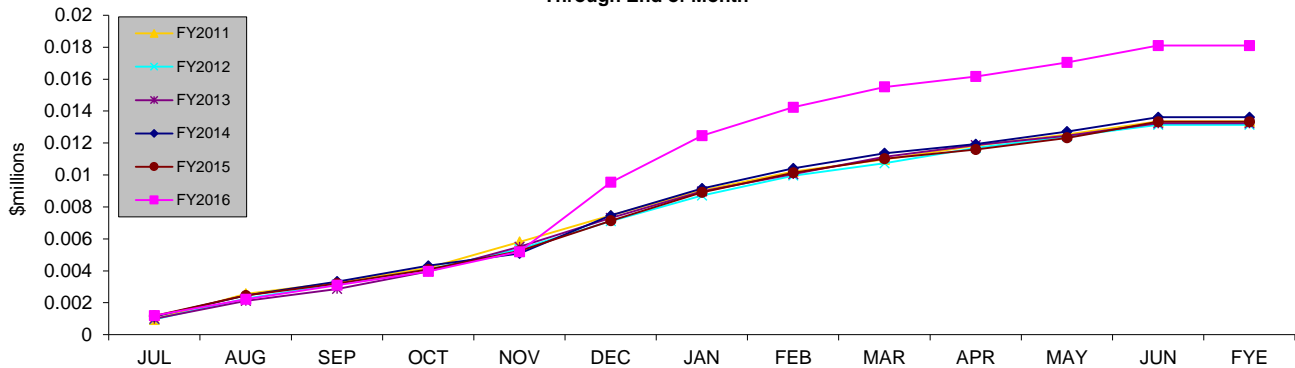

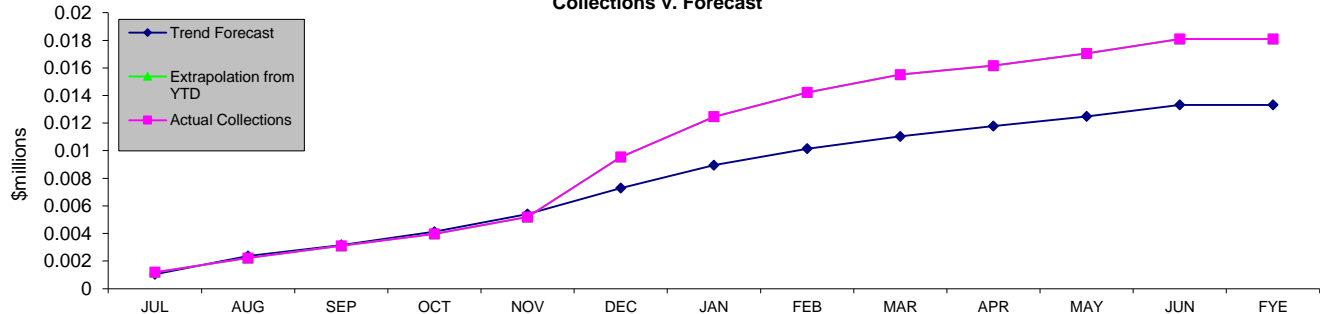

Collections v. Forecast**



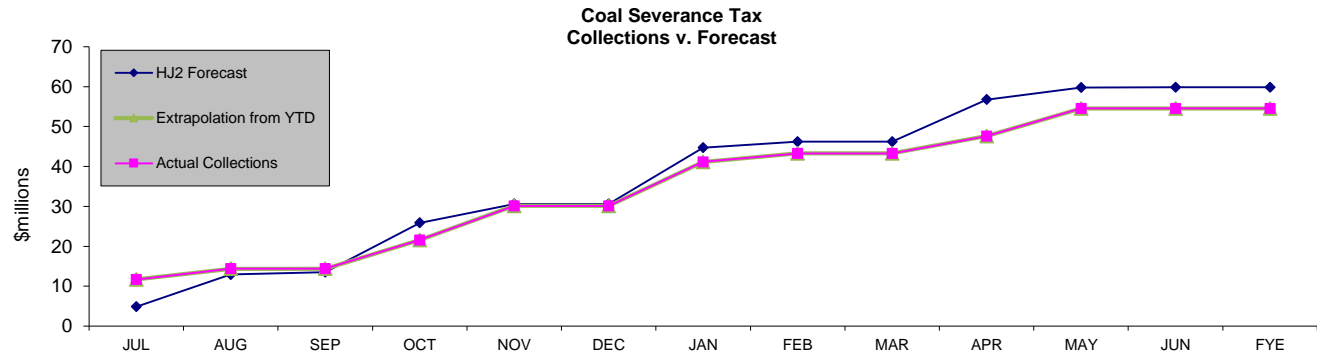
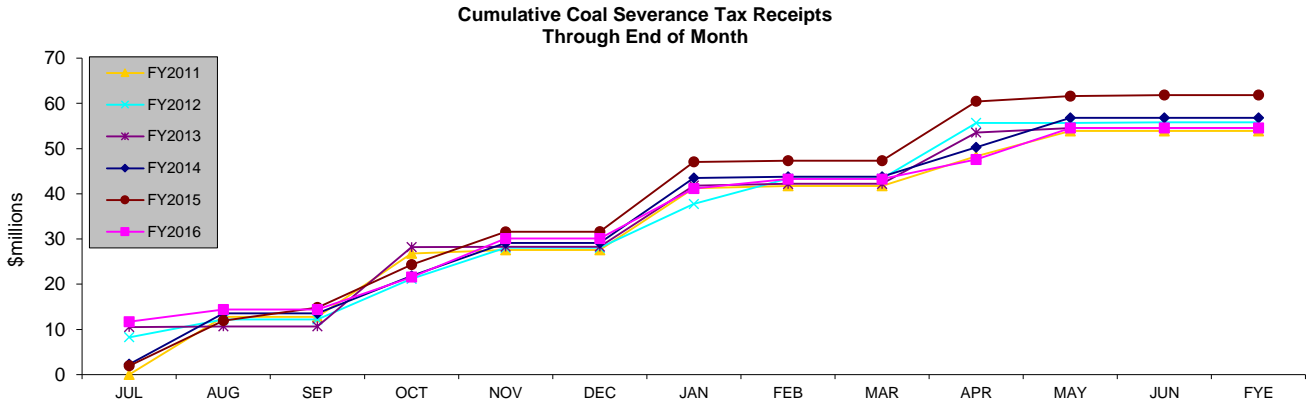

Collections v. Forecast**



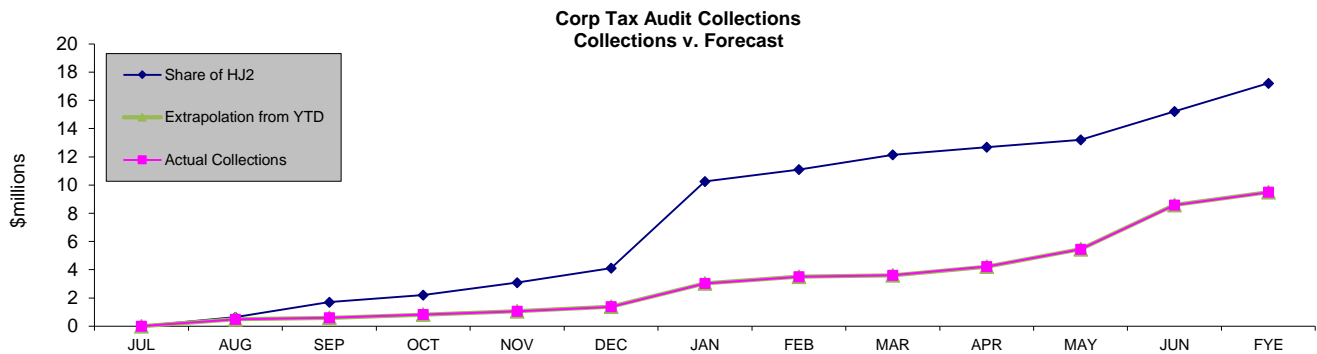
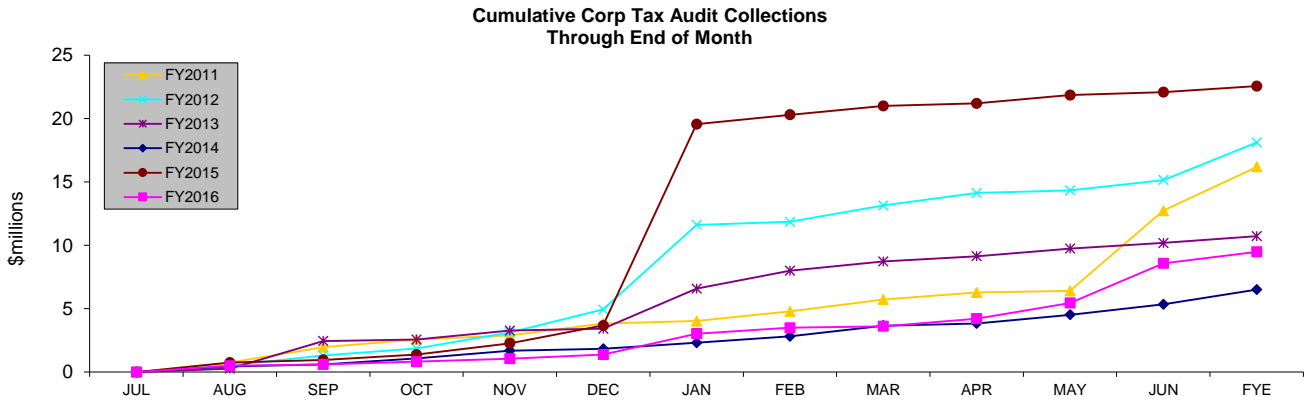

### Income Tax - Current Year Tax Collections v. Forecast



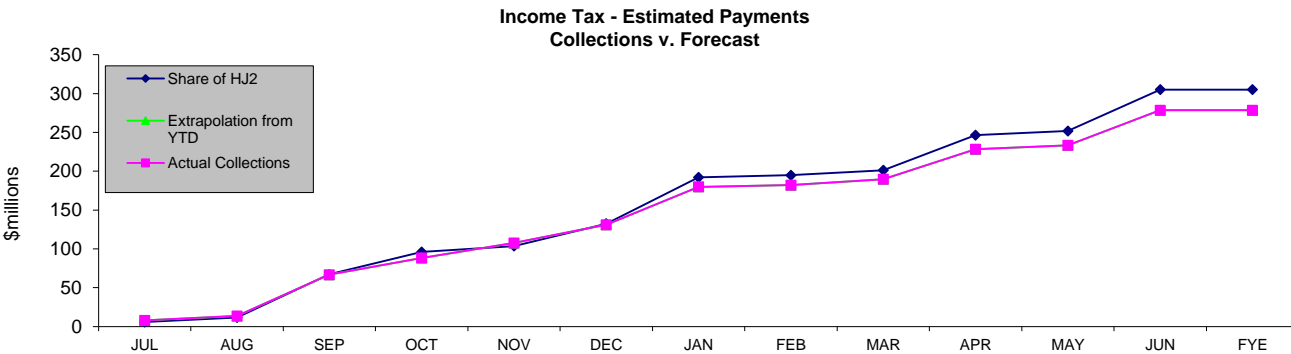
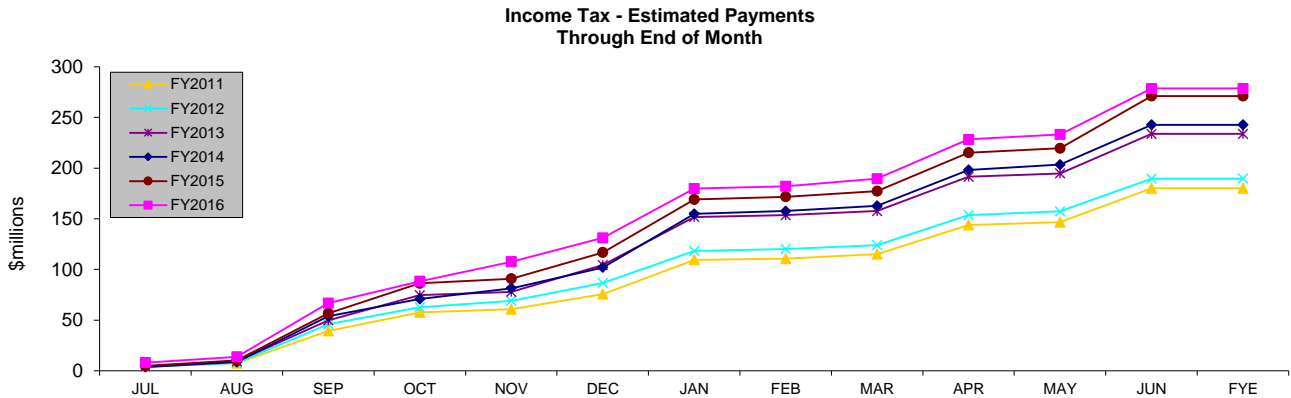

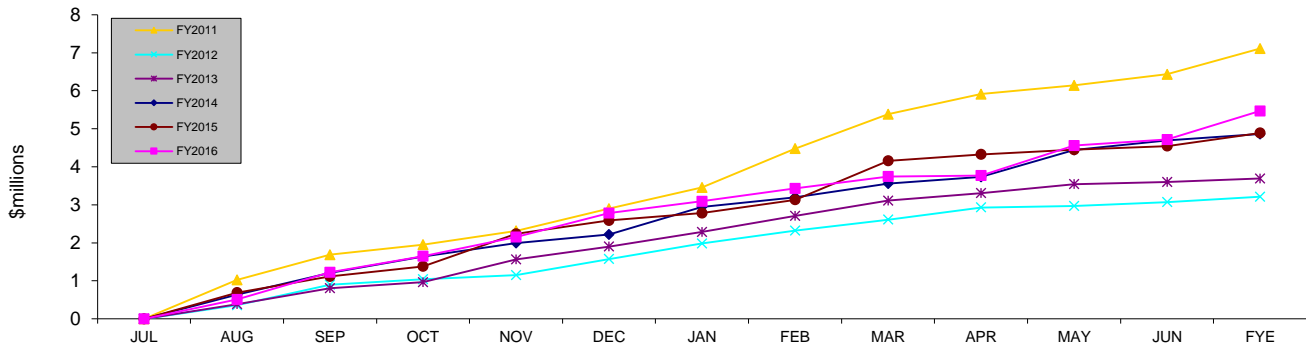

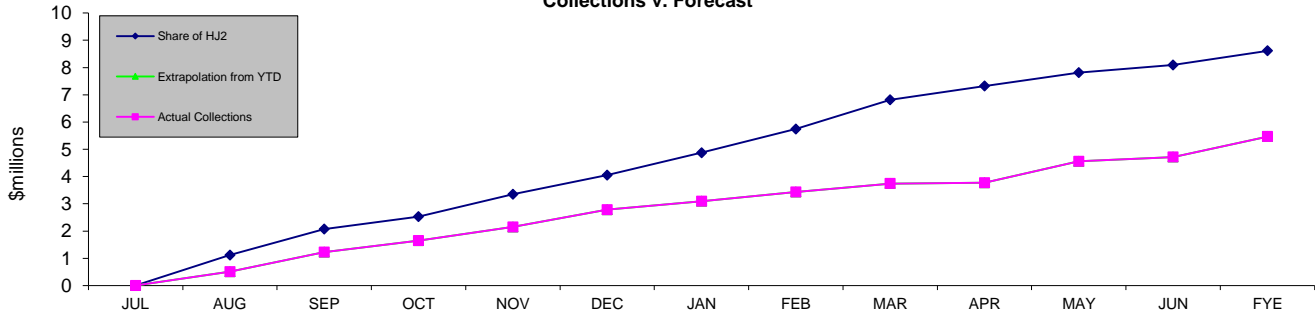

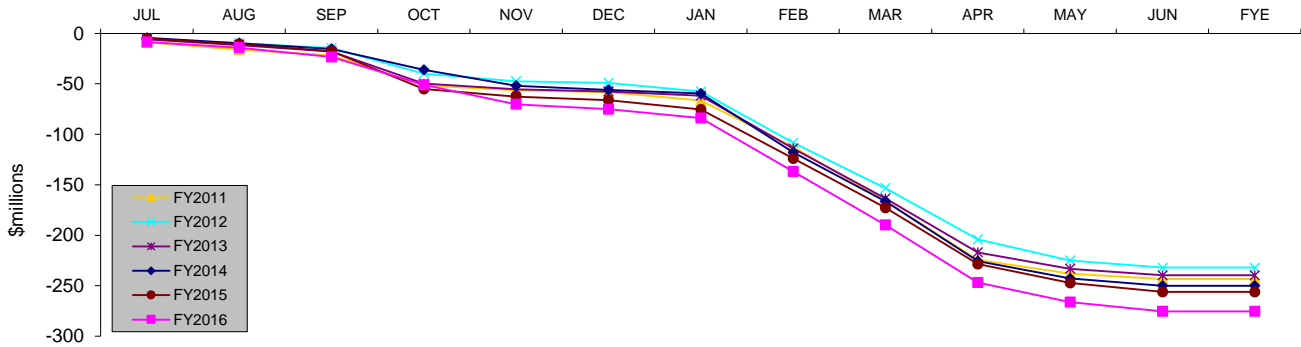

### Income Tax - Refunds Collections v. Forecast



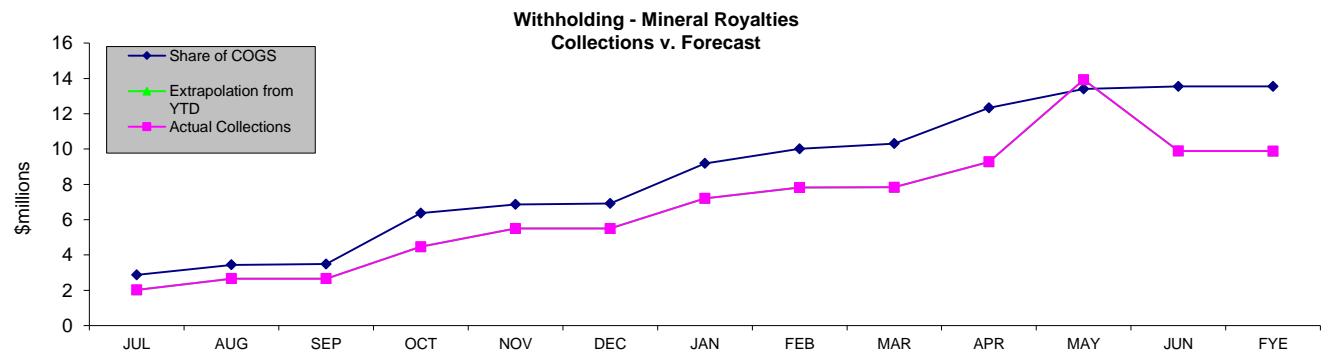
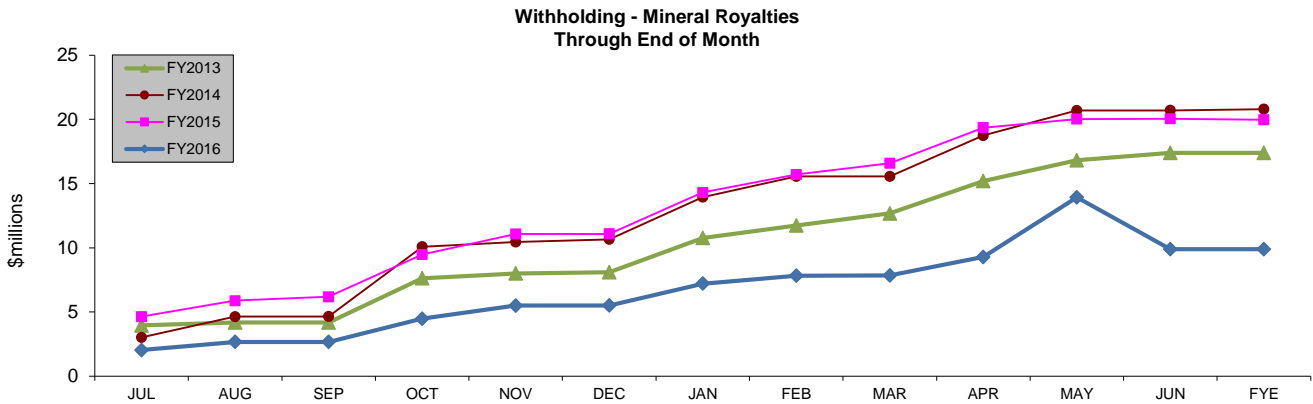

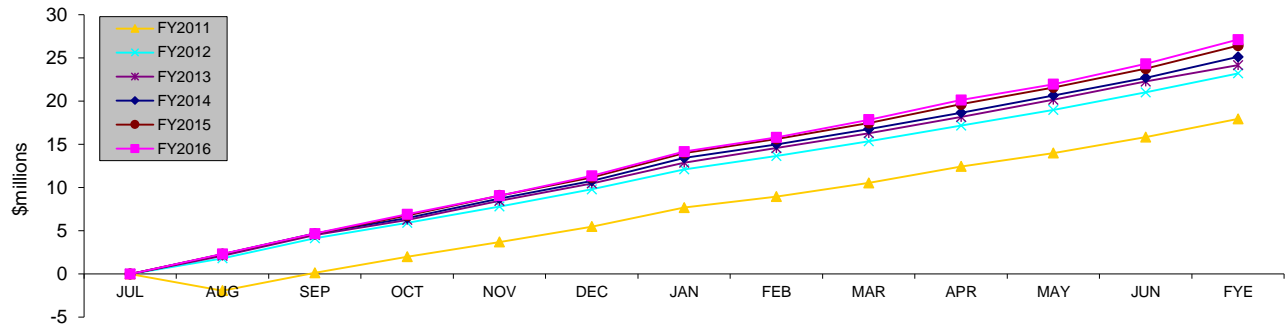

Collections v. Forecast**



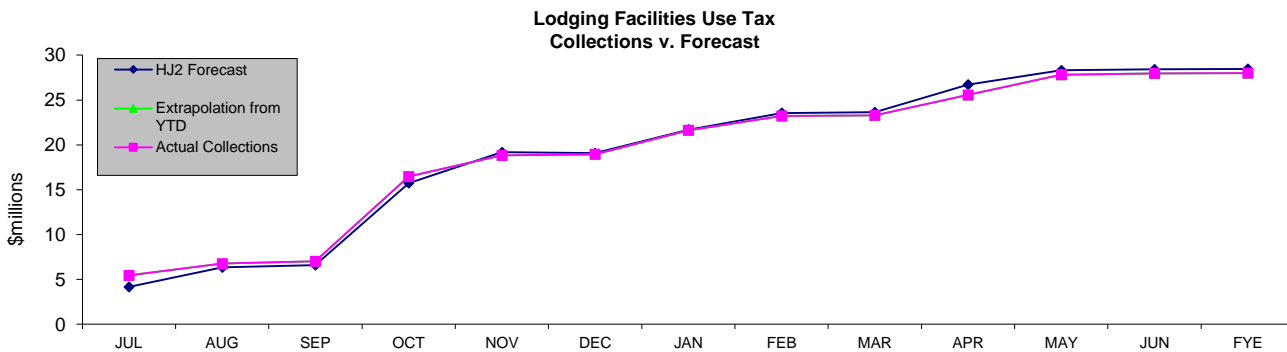
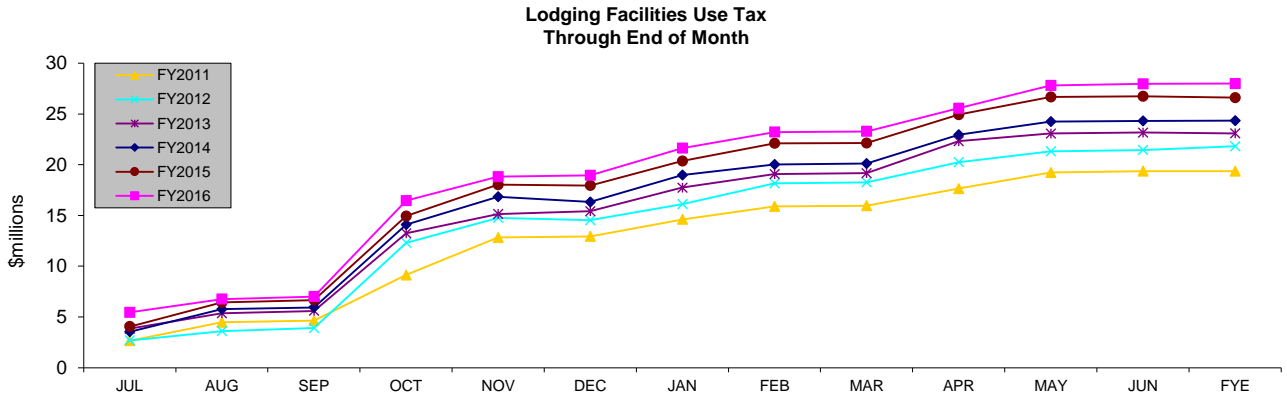

Collections v. Forecast**



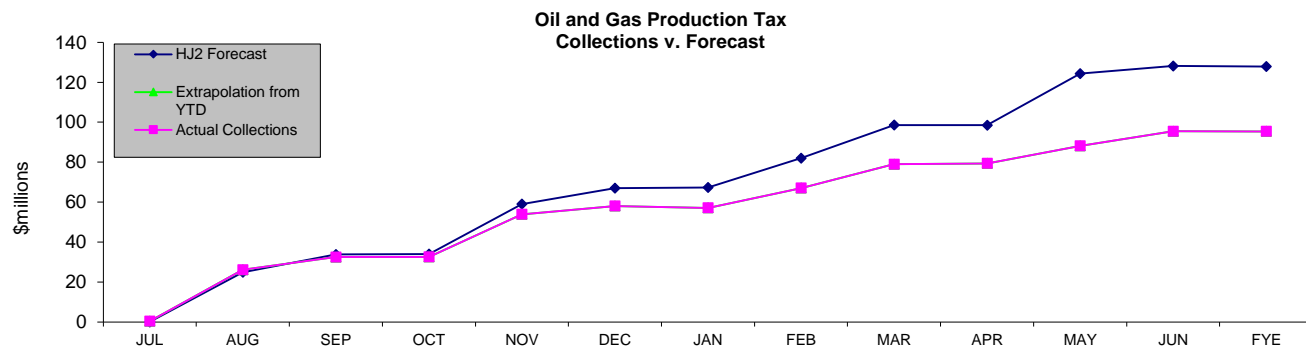
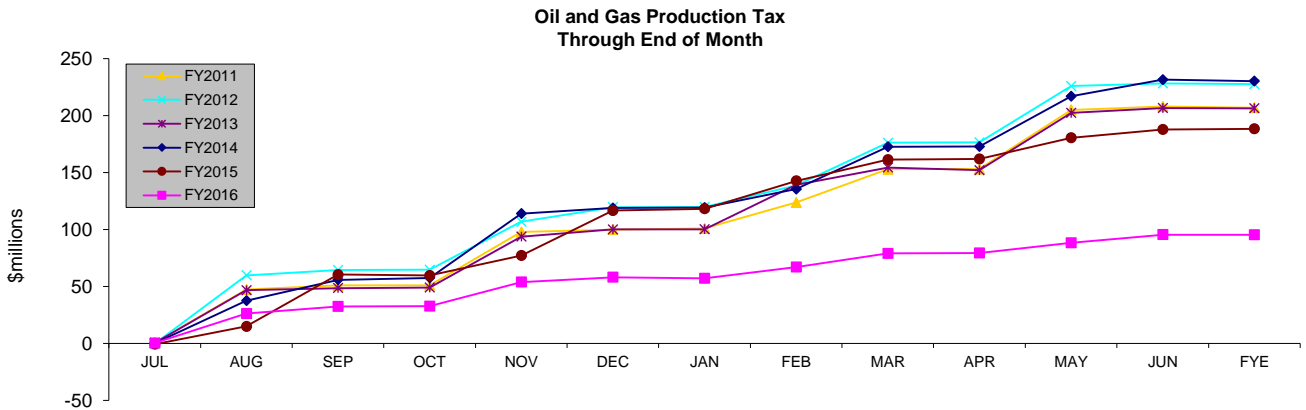

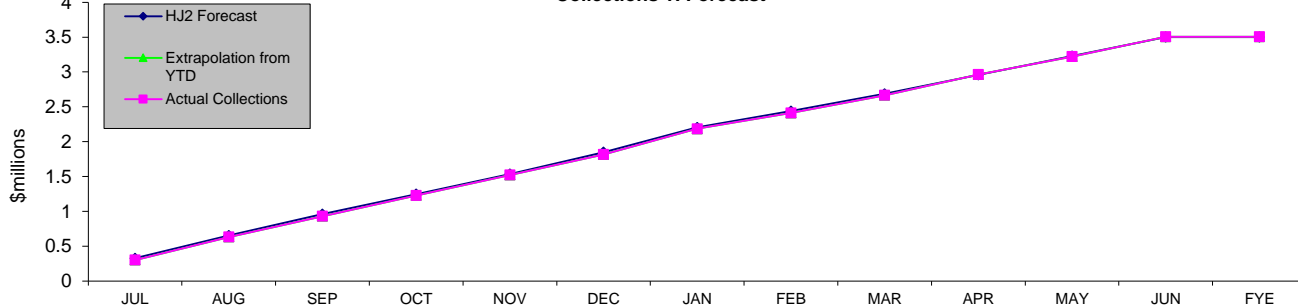

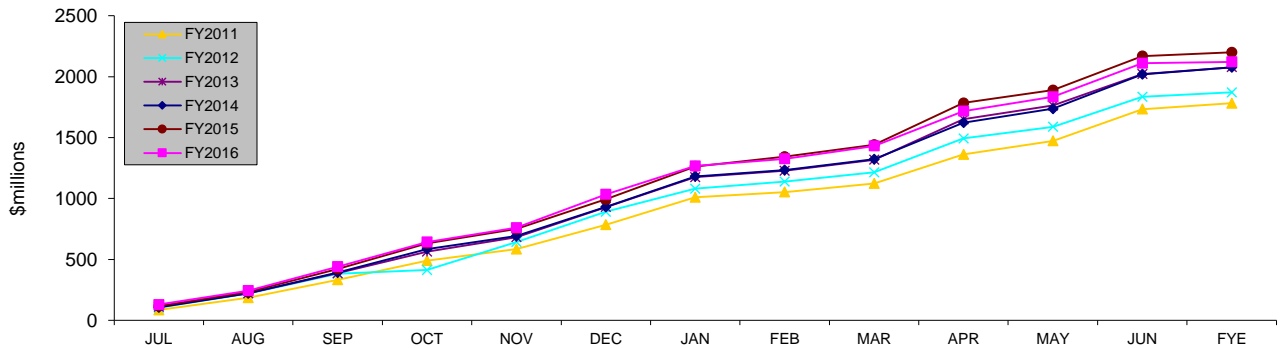

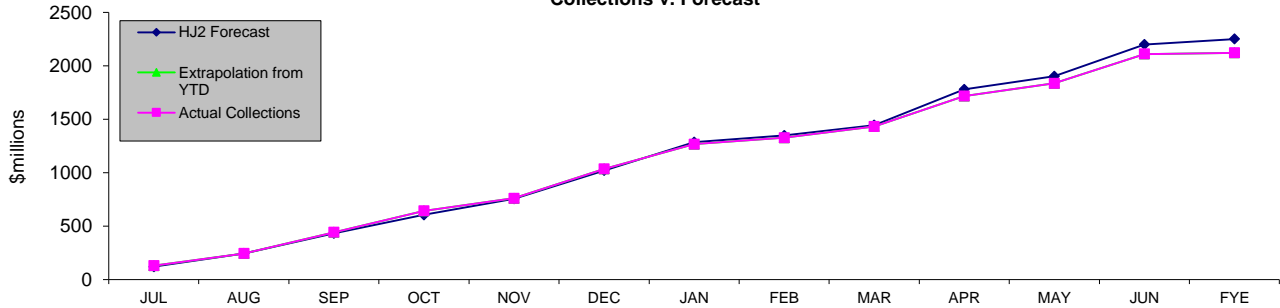
